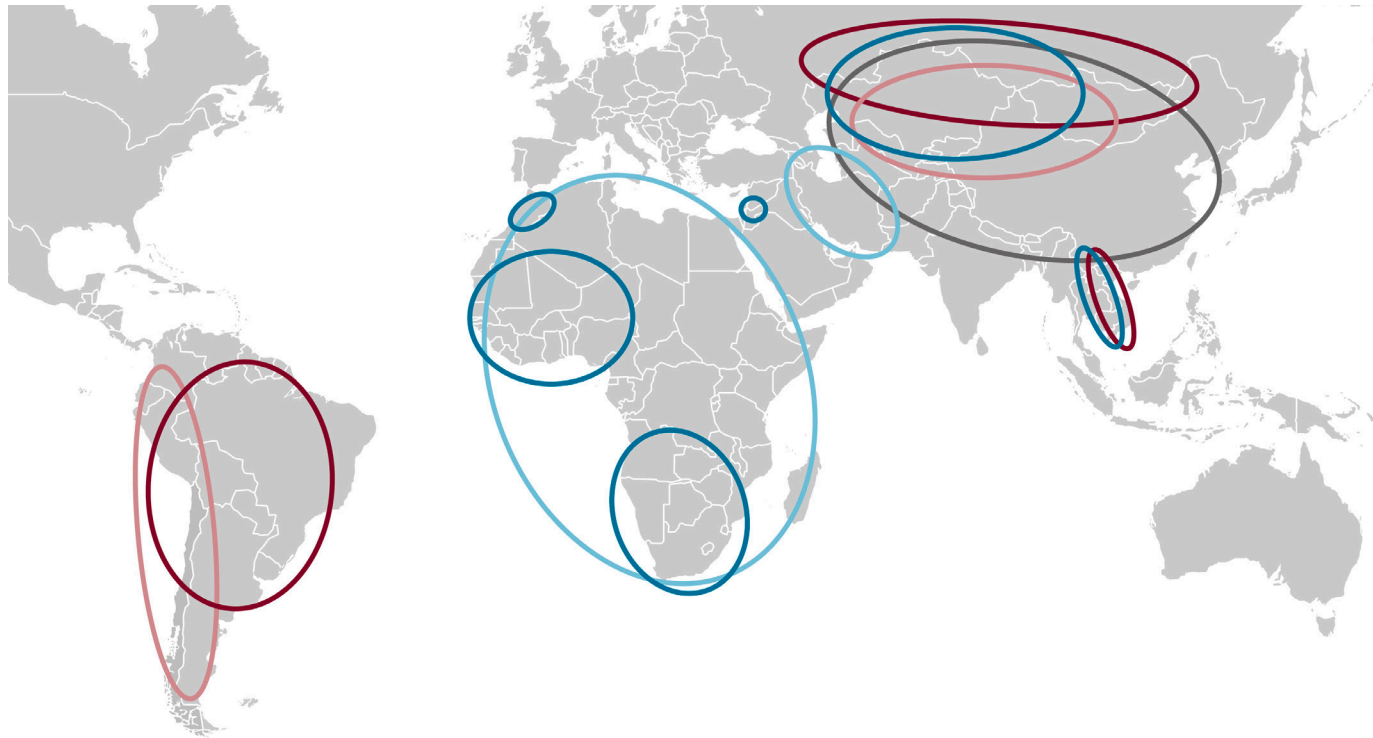

International interdisciplinary/transdisciplinary cooperation is expected.

Interdisciplinary collaborative projects which focus on several of the focal areas above and their interfaces are expressly welcome.

Topics and Regions

The „CLIENT II“ funding measure covers sustainable technologies and services in the following focal areas:

Resource efficiency and sustainable resource technologies

South America (especially Brazil, Chile, Peru),
Kazakhstan, Mongolia, Vietnam

Land management, Climate protection/energy efficiency, Adaptation to climate change

Southern and Western Africa (the countries participating in the Africa Centers SASSCAL and WASCAL), Central Asia (including the Central Asian regions of China and Russia), as well as Vietnam, Jordan and Morocco

Water management

Selected regions in China, Vietnam; Kazakhstan

Sustainable energy systems

Africa (especially countries in North Africa and at the African centres of SASSCAL and WASCAL), China and Iran

Natural hazards

Andes region (South America), Western and Central Asia
